Nottingham is staffed with 100% certified teachers. Staff participate in district and schoolwide professional development to enhance instructional skills. Staff also use student achievement data to drive the focus of their instruction. All students attending Nottingham, have an IEP and educational goals are set for students and adhered to as stated in their IEP. Since Nottingham is a school to work program, students are primarily instructed in independent living skills.

Because all students have an annual, formal IEP meeting, all parents are informed of any instructional standards students are responsible for learning, state and district assessments that students will participate in, and are given strategies that can be used at home for skill enrichment.

Nottingham hosts monthly PTO meetings where all parents are encouraged to come to get the most recent information about their student's progress and any updated information about what students are learning. We host a monthly "lunch with you student" day when parents are invited to have lunch with the students and participate in social activities. This is building a positive relationship between parents and their children as well as building a relationship with the school. It helps parents discover their child's interests, and they have hands-on opportunities to learn strategies to use at home. Homework packets were created for 3 cognitive levels and sent home for spring break.

The principal sends out Sunday messages updating parents about school information and, when appropriate, special events or trainings offered at school or elsewhere that may be beneficial to students and their families. The speech therapist team has trained parents in the use of communication devices, and we are working in partnership with The New American School to be sure we reach our families where English isn't their primary language.
