(09-10-24-01) To approve an acceptance of funds for the the period of August 2024 through August 2025 for Phase 1 of Renew America's Schools focusing on reducing energy consumption at 15 school buildings that align with the Student Goal Area of Health and Wellness with a donation of \$300,000 from the Department of Energy. This supports Pillar 5: Expand Private/Public Grant Engagements and Pillar 2: Partner with Community Allies.

(09-10-24-02) To approve the St. Louis Public Schools' group benefits costs for the plan year 2025, January 1, 2025, through

December 31, 2025, which includes Medical, Pharmacy, Dental, Vision, Short/Long Term Disability and Life/Accidental Death and Dismemberment insurance for all full-time permanent employees. The contract was the estimated cost based on 3,599 eligible employees is \$39,841,150. These services were publicly bid on through RFP 012-2223. This is the second year of the three-year renewal agreement for medical. Rate caps are in place through 2026 for Medical, Dental, Vision, Short/Long Term Disability and Life/Accidental Death and Dismemberment. This service supports Pillar 1: Excellent Schools, Goal 3B Teacher Retention, and 1D Efficient Equitable Staffing.

- (09-10-24-03) To approve an acceptance of funds for August 2024 through June 2025 for afterschool gun violence programs that align with the Student Goal Area of Health and Wellness with a donation of \$46,500 from DESE. - (09-10-24-04) To amend resolution number 05-14-24-48 a contract renewal with Dell Corporation as the standard vendor for technology purchases. Louis Children's Hospital Teen Outreach Program. This aligns with Transformation Plan 3.0, Pillar 4.4 (All Students Learn to Read and Succeed) and Student Success Goal 5 (Community Relations).
- (09-10-24-15) To approve the College and Career Readiness Community Partner Slate for in-kind (free) services for the period of September 11, 2024, through June 30, 2025. The partners include the Bolden Foundation, Missouri University Expansion and

Maryville University. This aligns with Transformation Plan 3.0, Pillar 4.4 (All Students Learn to Read and Succeed) and Student Success Goal 5 (Community Relations).

- (09-10-24-24) To approve the Literacy Community Partner Slate for the period of September 11, 2024 through June 30, 2025. The partners include Story Pirates. This aligns with Transformation Plan 3.0, Pillar 4.4 (All Students Learn to Read and Succeed) and Student Success Goal 5 (Community Relations).
- (09-10-24-25) To approve the Data Sharing Agreements in conjunction with MOUs for the period of September 11, 2024 through June 30, 2025. The partners include PreventED, St. Louis Public Library, and Springboard. This aligns with Transformation Plan 3.0, Pillar 4.4 (All Students Learn to Read and Succeed) and Student Success Goal 5 (Community Relations).
- NEW (09-10-24-26) To ratify and approve a contract extension with a Advance Security to provide daily security monitoring and response for all district schools and buildings, from September 11, 2024, through June 30, 2025, at a cost not to exceed (\$216,075.00) (pending performance) The contract will continue to support pillar 1: A system of excellent schools; Goal 1B: Safe and Secure Schools.
- NEW (09-10-24-27) To approve an acceptance of funds for the period of September 11, 2024 through October 31, 2024, to spend State Allotted AARPA Funds remaining from 2023-2024 for ARP-CHY McKinney-Vento Transportation Grant, at a cost not to exceed \$108,302.51. This supports Pillar 5: Expand Private/Public Grant Engagements and Pillar 2: Partner with Community Allies
- NEW (09-10-24-28) To approve the purchase of vouchers for the Praxis certification exams, the only Missouri-approved vendor, to provide an opportunity for current St. Louis Public Schools staff. Praxis exams, written by Educational Testing Service out of New Jersey, are notoriously expensive with minimum costs of \$116 each, and many aspiring teacher candidates in SLPS struggle to pay for this requirement to receive their teacher certification. Along with the supports provided from our district-sponsored Pathways to Certification, these vouchers will bridge the gap for up to 470 employees ranging from non-certified staff to aspiring principals. These vouchers would be active from September 11, 2024, through June 30, 2025 (vouchers expire one year after purchase). This is at a cost of \$49,150 to the District, paid out of our remaining ESSR DESE Teacher Retention Grant funds. This service will support Pillar 1: Excellent Schools, Goal 1.3: Innovative Staffing and Recruitment Practices. Pillar 3: Culturally Responsive Environments, Goal 3.2: High Quality and Effective Teachers.
- NEW (09-10-24-29) To approve a one-year contract with Nimble Connect, a certified teacher sourcing system accompanying our existing Nimble Applicant Tracking System. Nimble Connect will provide talent and applicant tracking services from September 11, 2024, through June 30, 2025, at a cost not exceeding \$50,000 to the district. This request supports Pillar 1: Excellent Schools, Goal 1.3: Innovative Staffing and Recruitment Practices. Pillar 3: Culturally Responsive Environments, Goal 3.2: High Quality and Effective Teachers.
- NEW (09-10-24-30) To approve a single source contract renewal with Panorama to provide culture and climate survey services to all SLPS students and staff within all schools and/or offices and Social emotional surveys to all students within all schools for the

period September 10, 2024 through July 30, 2025. This is at a cost not to exceed \$100,200 paid out of our remaining ESSR DESE Teacher Retention Grant funds. The contract amount has remained the same for the 24-25 SY. Pillar 1: Excellent Schools, Goal 1.3: Innovative Staffing and Recruitment Practices. Pillar 3: Culturally Responsive Environments, Pillar 5B, Cultivate Strategic Partnerships
