- Background information – How the Citywide Plan came to be

Background:

- Since 2019, the Board of Education of the City of St. Louis has grappled with the same tough question that presently challenges many cities across the United States:

“How do you best maximize the 21st-Century education you are charged with providing for the children of your city?”
- In this presentation, we will speak to ways in which we are attempting to answer that question

Background Continued:

- Facing a unique set of challenges, the District embarked on an 18-month **Community Visioning** process that explored school consolidation. The process, led by Emerging Wisdom, a local consulting firm included:
 - Individual meetings
 - Small group meetings with stakeholder groups spanning the community in both public and private sectors.
 - Public Forums where more than 1000 community members participated at six different school sites
 - Topics touched on included the need for more collaboration between the District and the City

Background Continued:

- In January 2021, the Board made the difficult decision to consolidate schools and resources to better serve every child attending SLPS. This resulted in the closure of seven schools and the redesign of another.
- The consolidation discussion and decision also yielded three other important Board recommendations including a:
 - Moratorium or “pause” on the opening of new schools in St. Louis
 - Development of a Citywide Plan for Education
 - TIF and Tax Abatement assessment
- An opportunity had presented itself to realign educational services in St. Louis. **The call for a Citywide Plan for Education was launched.**

- What is OUR STORY?

Why is There a Need for a CWP?

- St. Louis' present educational infrastructure is outdated and in need of redesign.
- The resulting DISCONNECT will continue to impede success until addressed. Here is what we mean:
 - St. Louis, once among the 10 largest U.S. cities, is now ranked 65th
 - Population dropped from 700,000 to 300,000 in a short time frame.
 - Over the past 20 years, St. Louis' school-age population dropped from 90,000 to 54,000 (40%).
 - Despite these facts, schools continue to open – and close – in the City.
- The timing is right to have this discussion and **The Board of Education is the only entity that has the power to lead it.**

- What the Plan **IS** and what it is **NOT**.

What the Citywide Plan IS:

- Concept for REIMAGINING education for all school-age children, a concept that was introduced by the Board of Education of the City of St. Louis through a resolution in February 2021.
- Chance to BRING TO LIGHT the actions being actively considered by decision makers, now and in the future.
- Opportunity to OPEN UP intellectually honest dialogue on how best to provide St. Louis children (and families) the education they deserve, no matter what school they attend.
- **Collaborative 18-month process** engaging all who share our vision for an intentional plan for education TODAY

What the Citywide Plan is **NOT**:

-  **NOT** a process created exclusively by the Board of Education, but a process for meaningful conversation involving all stakeholders in answering the question, “**How will we to move our educational system into the 21st Century?**”
-  **NOT** a restriction on existing or new district or charter school collaboration.
-  **NOT** intended to produce a system of schools with the same identities.
-  **NOT** a restriction of school choice, but an effort to create a fair and equitable system for all.
-  **NOT** designed by public schools to take funding from other city schools. By working together, the plan will ensure that **ALL** schools have the resources needed to provide the quality education and services that the children of St. Louis deserve.

Initial Goals:

- Initiate a productive conversation about education in St. Louis and engage the community in developing a Citywide Plan for Education.
- Shift the mindset of our community from being consumers of education as a commodity, concerned only with their particular choice-to being citizens for a better educational system overall.
- Create a better version of public education for all children. Schools, public and private, are currently achieving varied measures of success.
- Increase the number of students studying in St. Louis City public schools.
- Enhance economic development, which draws more families.
- Stand together and committed to creating 21st Century Schools for all.

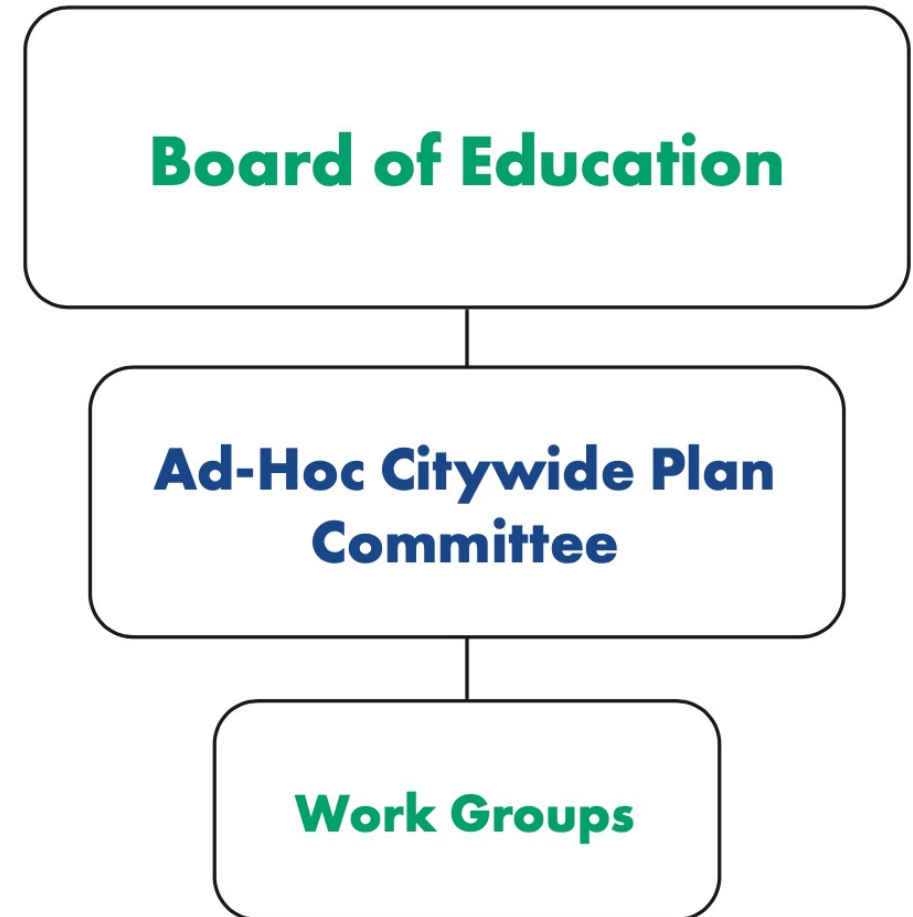


- Here is the Process

Citywide Plan Workgroups

- **School Experience**
 - Explore what is happening in St. Louis schools and identify needed improvements
- **Health, Wellness & Safety**
 - Identify the in- and out-of-school factors that promote or impede physical, mental and emotional health of students
- **Education Workforce**
 - Study the City's education labor market to identify needed improvements in order to create powerful teacher/leader pipelines
- **Logistics**
 - Examine the current physical infrastructure of the City's public education system in order to build an efficient system that serves current needs and promotes 21st. Century schools.
- **Community**
 - Understand the relationship between the City and its public education system and identify policy solutions to support and strengthen both.

Why Plan? Why Now?:

- **District Commitment** – We are all very excited to see where this process can take us and what it could mean to children of St. Louis.
