



FY2023-24 FINANCIAL OUTLOOK

- Strong Financial Position
 - ESSER III approximately 74% expended, ~\$30M remaining
 - FY2023 Anticipated Unrestricted Fund Balance: ~46%
- Strategic Financial Planning and Budgeting
 - Higher Administrative Costs
 - Planned Deficit Spending
- Future Concerns
 - ESSER Funding Cliff
 - Legislation Open Enrollment, Vouchers, Property Taxes, State Budget
