Real Estate Committee Meeting –MINUTES September 11, 2023

The Real Estate Committee meeting was called to order pursuant to RSMO §610.020 (2) in closed session on the above date at 3:09 PM.

The following matter(s) were discussed for possible consideration by the Board.

- A. A repeat of the July 10, 2023, request from Bermuda Investments, LLC (Jermal Seward) for a 6-month Option to purchase the Langston school at 5511 Wabada Ave. (listed at \$582,648) for \$350,000. A non-refundable Option Fee of \$5,000 will apply to the purchase price. Bermuda has partnered with Family and Workforce Centers of America and its subsidiary, Phoenix Residential, to renovate Langston into a community amenity providing supportive services like job training, financial counseling, and short-term housing for men and women re-entering society from the prison system. Letters of support and SLPS' proposed project summary form were attached to the July request.
- B. A request from Lutheran Development Group (Mark Stroker), the prospective purchaser of the Baden school, for a 90-day closing extension from 9/1/23 to 12/1/23. The original contract date is 9/24/19, and it is for the total asking price of \$331,453. The extension will require a \$2,500 non-refundable payment applicable to the closing purchase price.
- C. Offer from the Efficacy Consulting & Development (Yaphett El-Amin) to purchase Farragut Elementary School (listed for \$982,479.00) for \$600K or \$9.16/sf. Farragut's project description is to repurpose affordable housing for residents with 30, 60, and 80 percent average median income. Efficacy Consulting & Development (ECD) recommends rehabilitating Farragut to create a fullservice Senior Living Facility with 53 apartments, social enhancement services, exercise, lounging, and entertainment space.
