### **ACCEPTABLE FORMS OF PROOF OF RESIDENCY**

#### MUST PROVIDE THE FOLLOWING DOCUMENTS:

- 1) NOTARIZED PROOF OF RESIDENCY FORM OR LETTER SIGNED BY YOU AND THE PERSON YOU RESIDE/LIVE WITH.
- 2) A UTILITY BILL THAT INCLUDES THAT PERSON'S NAME AND ADDRESS.
- 3) THAT PERSON'S PHOTO ID; ORIGINAL OR COPY.

#### OR

- 1) CURRENT VOTER'S REGISTRATION CARD/FORM. ADDRESS MUST MATCH UTILITY BILL PROVIDED.
- 2) A UTILITY BILL THAT INCLUDES THE PERSON YOU RESIDE/LIVE WITH NAME AND ADDRESS.
- 3) THAT PERSON'S PHOTO ID; ORIGINAL OR COPY.

#### OR

- 1) OFFICIAL GOVERNMENT STATE/FEDERAL AWARD LETTER NO MORE THAN 90 DAYS OLD **ADDRESS MUST MATCH UTILITY BILL PROVIDED.**
- 2) A UTILITY BILL THAT INCLUDES THE PERSON YOU RESIDE/LIVE WITH NAME AND ADDRESS.
- 3) THAT PERSON'S PHOTO ID; ORIGINAL OR COPY.
